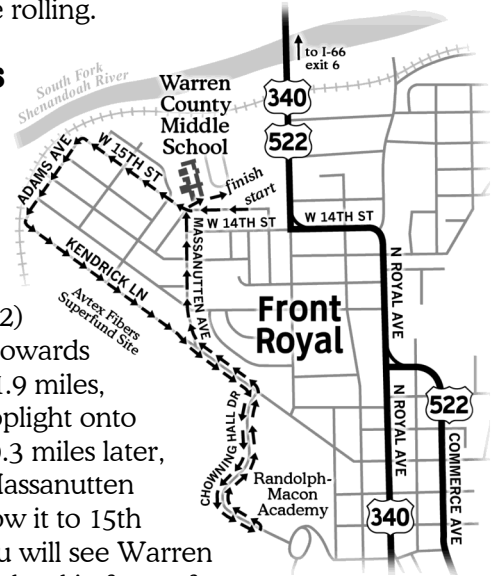

Course

A measured 5k (3.1 mile) route on paved roads through the northwestern part of Front Royal and the grounds of Randolph-Macon Academy. Mile one is mostly downhill or flat; mile two is mostly uphill; and the final 1.1 miles are rolling.

Directions

Warren County Middle School is at 500 West 15th Street in Front Royal, VA. Take I-66 to exit 6 (Routes 340/522) and head south towards Front Royal. In 1.9 miles, turn right at a stoplight onto W. 14th Street. 0.3 miles later, turn right onto Massanutten Avenue and follow it to 15th Street, where you will see Warren County Middle School in front of you. Turn right onto 15th Street and park in the school lot.
